In forested areas, all exterior materials shall be of deep earth hues such as dark browns, greens and rusts. In grasslands or sagebrush areas, all exterior materials shall be of the same earth and vegetative tones as the predominant colors of the site. Highly reflective surfaces and colors are not allowed."

I, the owner, acknowledge that if any work has commenced prior to the approval of the DRC, I am liable for all costs necessary to bring the work into compliance with the CC&R'S (declaration) or design guidelines. Any changes made to pre-approved plans must be resubmitted for final review.
